Meeting Minutes July 21, 2022

Call to Order: The meeting was called to order at 7:00 PM by Steve Niebler, Chairman. There was no Pledge of Allegiance given the meeting was virtual as well as in-person.

PRESENT: Steve Toddes, Tom Demko, Robin Fitzpatrick and Erin Peddigree.

VIRTUAL PRESENCE: Steve Niebler, Jimmy Phelps and Keith Ulrich

ABSENT: Max Laing resigned his position as a member of the Board.

PUBLIC: Chuck Stangor, Gettysburg Connection, attend with a virtual presence.

The Agenda was presented for review. A motion was made by Keith Ulrich seconded by Tom Demko and was unanimously approved by the board.

The May Meeting Minutes were presented for review and approval. Tom Demko moved, and Steve Toddes seconded approval of the minutes as distributed. Motion carried unanimously.

**PUBLIC COMMENTS**: The only attendee representing the public was Chuck Stangor who had no comments at this time.

Erin Pedigree provided the Treasurer's Report. A copy of the ACNB Bank Checking Account and Reconciliation Summary thereof was provided to each member of the Board as was information regarding the Members 1st Federal Credit Union Savings Account. The reports capture months ending 5/31/2022 and 6/30/2022. Tom Demko asked about the costs associated with the recent purchases of a tractor and golfcart. Erin replied that they are not reflected in the financial report and will be included in July's statements. A motion to accept the financials for the months of May and June was made.

Tom Demko moved to accept the reports and Steve Toddes seconded it. The motion was passed unanimously without any further questions.

**New Business- Erin** reported that the much-needed tractor and golfcart have been purchased.

Erin Pedigree submitted the Operations Report which was included in today's packet.

A utilities update was provided. Straban Township donated ten picnic tables. A thank you will be sent to them. Ongoing damage to the amphitheater has been noticed. Tiles from the inside wall have become loose, perhaps because of water damage to the roof. Several are broken and more missing. A request to the Optimist Club to consider the repair of the roof will be made. Tiles will be reattached when it is safe to do so. Robin Fitzpatrick reported her optimism in this regard.

Events update for the months of May, June and part of July was also provided. The park is seeing heavy use. A discussion regarding rental fees of the assembly room began without conclusion. Consideration is being given to fee structure such that charges may be lower for residents of the county and higher for those outside.

The Independence Day Celebration was a success. Approximately 5,000 people were in attendance. The event brought in \$20,000 which is a \$6,000 increase from year one.

The Chamber of Gettysburg and Adams County will hold their mixer this evening in the Assembly Room. GARA is this month's sponsor.

A discussion was held regarding the need for new employees to replace those who are retiring. Erin is preparing a job description and will advertise.

Erin is preparing an application that she will submit to DCNR for a Small Town Grant for costs associated with the renovation of restrooms and playground equipment.

There were no announcements from members of the Board. Meeting adjourned at 8 pm.
